Established in 1998 as a service delivery Crown Corporation, the BC Oil and Gas Commission (Commission) is the provincial single-window regulatory agency responsible for regulating oil and gas activities in British Columbia, including exploration, development, pipeline transportation and reclamation. The Commission is accountable to the Ministry of Energy, Mines and Low Carbon Innovation, and acts in accordance with the *Oil and Gas Activities Act (OGAA)*.

The Commission is highly committed to protecting public safety, respecting those who are affected, and safeguarding the environment through the regulation of the sound development of oil, gas, liquefied natural gas and geothermal resources in British Columbia. The Commission consults with First Nations governments and engages with landowners, communities, and Industry; reviews and assesses applications for industry activity; and ensures that industry complies with provincial legislation. Regulatory responsibility extends from the exploration and development phases, through to facilities, operation, and ultimately reclamation. They bring strong relationships with governmental representatives, direct experience working with Indigenous partners, and an understanding of the industries regulated. The new Commissioner will be an excellent communicator and a person of unassailable integrity and character who provides visionary and innovative leadership; encourages collegiality and collaboration; and demonstrates a strong commitment to equity, diversity, and inclusion.
